Gerli Metalli requires that all third parties have appropriate Anti-Bribery & Corruption policies and procedures in place that comply with all applicable local and international laws and, ensure they do not assist or participate in briberies, corruption, extortion or other fraudulent practices in any country. Corporate entertainment and gifts given or received must be appropriate and authorised and should not be used to obtain favourable treatment. We maintain an Anti-Bribery & Corruption policy and a related education program for employees. (see our document: Rating di legality)

### **Anti-Money Laundering**

Gerli Metalli maintains an Anti-Money Laundering Policy. We will not participate or assist in any third-party performing money laundering activity. Anyone concerned who knows or even suspect that an existing or prospective commercial partner is seeking to be or engaged in money laundering must report it immediately to the Management.

### **Charities and Donations**

Gerli Metalli does not allow funds or resources to be used as a contribution towards political campaigns of any parties, candidates or any affiliated organisations and does not use charitable donations as a substitute for political payments. Gerli Metalli expects our third parties to adopt the same ethical conduct.

### **Conflict Minerals**

Gerli Metalli's main business is metal trading. We support humanitarian goals to end all violent conflict in these regions, which sometimes have been partially financed by the exploitation and trade of conflict minerals. To do so, Gerli Metalli goes to extreme lengths to ensure that such metals are not directly or indirectly sourced from such regions.
